Accuracy of Your Pay Statements

It is every employee's responsibility to review his / her Pay Statements to ensure the information is accurate. This includes verifying your income, deductions and taxable benefits amounts.

Examples of errors could include Timesheet errors, input errors, etc. In the case of transfers, employees may not be paying the correct amount for LTD insurance or being assessed an incorrect taxable benefit as part of their annual income for tax purposes.

Therefore, always review your pay statements and contact the Pay Office immediately if you discover any discrepancies. We are always available to assist you in ensuring all information on your Pay Statement is accurate.
